<b>Evaluation</b>	Expository method and thematic discussions with the presentation of practical work by students. The student may choose to final assessment or by continuous assessment. In this model the student must make a written examination and an oral exam. After completion of the written examination in accordance with the results obtained, the student will fail (downgrading to 7.5 points) or have mandatory oral (rank greater than or equal to 7.5 points). In continuous assessment a student must attend at least two thirds of the classes. Met this criterion, the assessment is made for participation in oral and written eight research themes, often written by the end of the semester and the oral test. The final grade obtained in the discipline is so weighted: 50% often and 50% of the arithmetic average of the marks obtained in the research themes.
